COOPERATIVE AGREEMENT

Parkway Blvd & 3100 South Over I-215; Bridge Joint Mod, OC659

THIS AGREEMENT, made and entered into this _____ day of _____ 2014, by and between the **UTAH DEPARTMENT OF TRANSPORTATION**, hereinafter referred to as “**UDOT**”, and **West Valley City**, a political subdivision of the State of Utah hereinafter referred to as the “**City**.”

RECITALS

WHEREAS, the City plans constructing a project called Parkway Blvd & 3100 South I-215 Bridge Deck Rehab (“Project”); and

WHEREAS, West Valley City desires to rehabilitate the decks of the bridges over I-215 at Parkway Blvd and 3100 South.

WHEREAS, UDOT desires to contribute funds to the Project to reconstruct the expansion joints on the bridges.

AGREEMENT

NOW THEREFORE, it is agreed by and between the parties hereto as follows:

1. The City shall construct the Project in compliance with the plan set contained Exhibit A, which is incorporated by reference. The Project will be constructed before the end of 2015. Any changes to the plan set must be approved by UDOT.
2. UDOT will pay the City \$100,000.00 within 30 days after execution of this Agreement. In the event the City does not construct the Project within the time frame stated in paragraph one, the City will promptly refund the money to UDOT.
3. The City will assure compliance of the Project with all applicable State and Federal environmental regulations and permitting requirements.
4. This Agreement may be executed in counterparts by the parties.
5. This Agreement shall be governed by the laws of the State of Utah both as to interpretation and performance.
6. This Agreement does not create any type of agency relationship, joint venture, or partnership between UDOT and the City.

This Agreement, together with all exhibits and attachments, constitutes the entire agreement between the parties and supersedes any prior understandings, agreements, or representations, verbal or written. No subsequent modification or amendments will be valid unless in writing and signed by both parties.
- 8. Each party represents that it has the authority to enter into this Agreement.


